In accordance with clause 2.5.10 of the Market Rules, the IMO has extended the timeframe

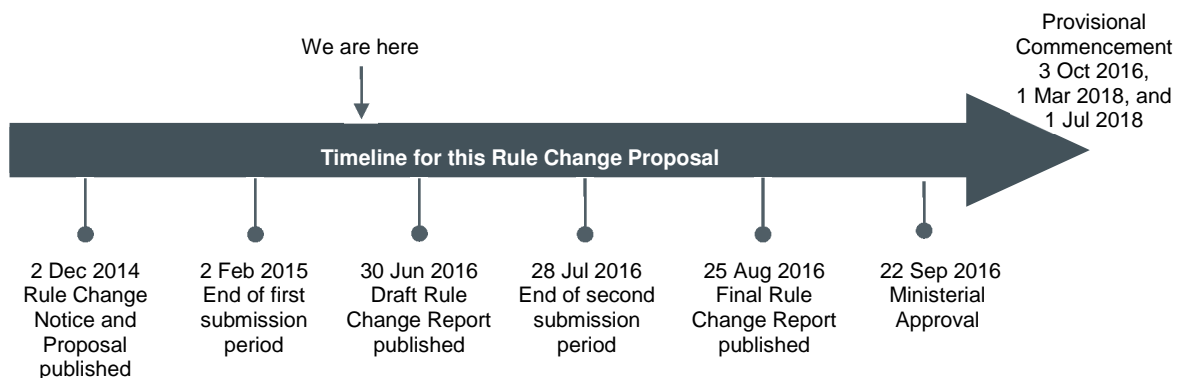
If the IMO's decision is to approve the Rule Change Proposal, the following steps will apply:
