



Rule Change Extension Notice: Reduced Frequency of Determining the Energy Price Limits and Maximum Reserve Capacity Price (RC_2014_05)

In accordance with clause 2.5.10 of the Market Rules, the IMO has extended the timeframe for the publication for the Draft Rule Change Report for the Rule Change Proposal: Reduced Frequency of Determining the Energy Price Limits and Maximum Reserve Capacity Price (RC_2014_05) by 15 Business Days until **Thursday 21 May 2015**. The Final Rule Change Report was proposed to be released on 30 April 2015.

Dates for subsequent steps of the rule change process have been adjusted accordingly.
