### 3. Prohibition on commercial fishing

- (1) A person must not fish for a commercial purpose by any means in the waters of the Shoalwater Islands Marine Park.
- (2) Subclause (1) does not apply in respect of the General Use Area.

### 4. Exceptions to prohibition

Subclause 3(1) does not apply to a person who ó

- (a) holds a commercial fishing licence; and
- (b) engages in an activity specified in Schedule 6.

## Schedule 1

### Shoalwater Islands Marine Park

All waters bounded by a line commencing west northwest of Cape Peron at the intersection of 32° 15.660' south latitude and 115° 40.089' east longitude; thence generally north easterly along the geodesic to the intersection with 32° 14.831' south latitude and 115° 42.093' east longitude and the causeway extending from Garden Island to the mainland; thence generally south easterly and south westerly along the western side of the causeway to the intersection with 32° 16.178' south latitude; thence west along the parallel to the intersection with the high water mark on the mainland; thence generally westerly and southerly along the high water mark of Shoalwater Bay, Safety Bay and Warnbro Sound to the intersection with 115° 43.889' east longitude; thence north along the meridian to the intersection with 32° 21.710' south latitude; thence west northwest of Cape Lyade;

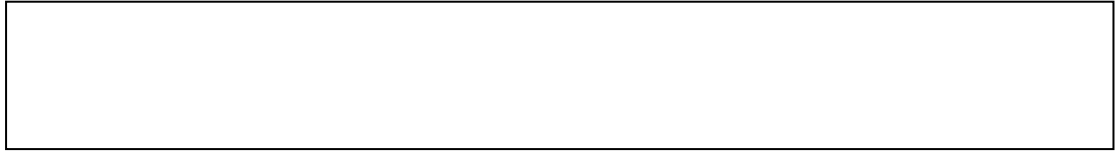
